Boat Owners

You are reminded that no TPSC Boat Licence will be issued until proof of Insurance, BW River Licence/explorer licence and Clubs Scrutineering Certificate have been received by the Membership Secretary, together with a correctly completed application form and all appropriate fees.

Notes on Membership and Completing the Application Form

- 1) NO-one is permitted to use the TPSC facilities until they are in POSSESSION of a current TPSC membership card. "Current" means one which covers the date or dates on which you wish to use TPSC facilities or waters.
- 2) A day ticket when issued also acts as a membership card, FOR THE DAY ONLY.
- 3) British Waterways Board River Licence or cover notes can be obtained from Chris Donger, with your renewal notice form.
- 4) Scrutineering clearance forms are issued by the Safety Officer when the boat has been inspected and passed.
- 5) The joining fee has only to be paid by those joining for the FIRST TIME WITH A BOAT or re-joining after a previous membership has lapsed and not been renewed on a continuous basis.
- 6) The boats of prospective NEW MEMBERS will only be admitted to the TPSC upon final approval of the Committee at its earliest meeting following satisfactory Scrutiny.
- 7) Junior members are not allowed to drive TPSC registered boats at speeds above the British Waterways river limit. Day members over the age of 17 are only allowed to drive TPSC registered boats above the BW speed restrictions if they have passed the TPSC or BWSF BOAT HANDLING TEST and can produce the certificate.
- 8) A £10 re-registration fee will be charged when an existing boat is changed and a new one registered during the season.
- 9) The Constitution requires that anyone using TPSC waters or facilities must be able to produce a valid membership card whenever asked to do so by a Club Official. Don't be offended if they ask to see yours, it is for your protection and for the Club.
- 10) Please do not send cash, make all cheques payable to Trent Power Boat and Ski Club or just "TPSC".
- 11) Boat owners are reminded that the TPSC and the British Waterways Licence must be clearly visible on the boat. Failure to display these licences could result in expulsion from the Club.
- 12) ANYONE or ANY BOAT found to be using the Clubs Licensed Zones, Facilities or Waters, without the appropriate membership or documentation will be suspended from the TPSC for a minimum period of ONE YEAR. This means that the BOAT will be banned no matter who was using or driving it at the time.
